## I. CHARACTER TABLE OF $C_{3 v}$

Character table for point group $C_{3 v}$ is shown in Table S 1 , and Mulliken symbols $\left(A_{1}, A_{2}, E\right)$ for some irreducible representations are also listed.

Note: data are from Ref. 1. I means identity, $S_{z}$ stands for the $z$ competent of an axial vector ( $\mathbf{S}=\mathbf{r} \times \mathbf{p}$ ).
According to the above table:

E \otimes D^{1 / 2}=\Gamma_{4} \oplus \Gamma_{5} \oplus \Gamma_{6}
\end{array}\right.

where $D^{1 / 2}$ is the representation matrix of spin. From Eq. S1, we can see that $A_{1} / A_{2}$ state transfers into $\Gamma_{4}$, while $E$ state splits into $\Gamma_{4}, \Gamma_{5}$, and $\Gamma_{6}$ sates when spin orbit coupling (SOC) effects are considered. $\Gamma_{5}$ and $\Gamma_{6}$ transfer into each other under the time reversal operator $T$ :

and the matrix of time reversal operator for the bases of $\left(\Gamma_{5}, \Gamma_{6}\right)$ is

where $K$ is complex conjugate operator. Therefore, these two states are Kramers pair, and they are degenerate at time reversal symmetry point. Along the $\Gamma-A(\Delta)$ path, we prefer $\Delta_{4}, \Delta_{5}$, and $\Delta_{6} \operatorname{instead}$ of $\Gamma_{4}, \Gamma_{5}$, and $\Gamma_{6}$.

## II. $k \cdot p$ DERIVATION

The little group of $A$ point is $C_{3 v} \otimes 1^{\prime}\left(1^{\prime}=\{\mathbb{I}, T\}\right)$. There are two generators of $C_{3 v}$ including a threefold rotational symmetry $C_{3 z}(-x / 2-\sqrt{3} y / 2, \sqrt{3} x / 2-y / 2, z)$ and mirror symmetry $\sigma_{y z}(-x, y, z)$. Consequently, the related symmetry representation matrices under the bases of $\left\{\Delta_{4}, \Delta_{5}, \Delta_{6}\right\}$ are given by

According to invariant theory:

where $R$ is a symmetry operator, the derived effective Hamiltonian around $A$ point that considers first-order $k$ terms for off-diagonal matrix elements and second-order $k$ terms for diagonal matrix elements is:

where $\varepsilon_{0}(\mathbf{q})=C_{0}+C_{1} q_{z}^{2}+C_{2}\left(q_{x}^{2}+q_{y}^{2}\right), M(\mathbf{q})=M_{0}-M_{1} q_{z}^{2}-M_{2}\left(q_{x}^{2}+q_{y}^{2}\right), \mathbf{q}=\mathbf{k}-\mathbf{A}, q_{+}=q_{x}+i q_{y}$, and $q_{-}=q_{x}-i q_{y}$. $A$ is a complex number, while $B$ and $C$ are real numbers.

## III. CHIRALITY OF EACH TDP

By using similar method that drives $k \cdot p$ effective Hamiltonian near $A$ point, we can get the effective Hamiltonian near the TDPs. The $3 \times 3$ effective Hamiltonian around the TDP (T1) by $\Delta_{4}$ and $\Delta_{5}$ bands keeping only linear order terms for matrix elements is as follows:

-i \beta p_{-} & \alpha p_{z} & -\gamma p_{+} \\
\gamma^{*} p_{+} & -\gamma^{*} p_{-} & -\alpha p_{z}
\end{array}\right]
$$

where $\mathbf{p}=\mathbf{q}-\mathbf{q}_{T 1}=\left(p_{x}, p_{y}, p_{z}\right), \alpha, \beta$ and $\eta$ are real numbers, and $\gamma$ is a complex number.
The $2 \times 2$ Hamiltonian of the crossing point of $\Delta_{4 \uparrow}$ and $\Delta_{5}$ is:

\alpha p_{z} & \gamma p_{-}  \tag{S10}\\
\gamma^{*} p_{+} & -\alpha p_{z}
\end{array}\right],

and the effective Hamiltonian of the crossing point of $\Delta_{4 \downarrow}$ and $\Delta_{5}$ is:

H_{\Delta_{4} \downarrow, \Delta_{5}}=\eta p_{z}+\left[\begin{array}{cc}
\alpha p_{z} & -\gamma p_{+}  \tag{S11}\\
-\gamma^{*} p_{-} & -\alpha p_{z}
\end{array}\right] .

Any $2 \times 2$ Hermitian matrix can be expanded by the Pauli matrices and the identity matrix:

where $\sigma_{0}$ is a $2 \times 2$ identity matrix, $i, j=x, y, z, \sigma_{j}$ are one of three Pauli matrices. So Eq. S10 can be rewrote as:

and Eq. S11 can be rewrote as:

where $\gamma_{R}$ and $\gamma_{I}$ are the real and imaginary part of $\gamma$, respectively. So

V_{\Delta_{4 \downarrow}, \Delta_{5}} \equiv\left[v_{i j}\right]_{\Delta_{4 \downarrow}, \Delta_{5}}=\left[\begin{array}{ccc}
-\gamma_{R} & \gamma_{I} & 0  \tag{S16}\\
\gamma_{I} & \gamma_{R} & 0 \\
0 & 0 & \alpha
\end{array}\right] .

According to Ref. 2, the chirality of a $2 \times 2$ Hamiltonian $\chi=\operatorname{sgn}[\operatorname{det}(V)]$, so

Similarly, the $3 \times 3$ effective Hamiltonian around the TDP by $\Delta_{4}$ and $\Delta_{6}$ bands is:

H_{\Delta_{4}, \Delta_{6}}=\eta^{\prime} p_{z}+\left[\begin{array}{ccc}
\alpha^{\prime} p_{z} & i \beta^{\prime} p_{+} & \gamma^{\prime} p_{-}  \tag{S18}\\
-i \beta^{\prime} p_{-} & \alpha^{\prime} p_{z} & \gamma^{\prime} p_{+} \\
\gamma^{\prime *} p_{+} & \gamma^{\prime *} p_{-} & -\alpha^{\prime} p_{z}
\end{array}\right]
$$

where $\alpha^{\prime}, \beta^{\prime}$, and $\eta^{\prime}$ are real numbers and $\gamma^{\prime}$ is a complex number. Using similar method, we can prove that one TDP formed by $\Delta_{4}$ and $\Delta_{6}$ bands can also be viewed as two Weyl points with opposite chirality. Moreover, the results are invariant with the values of above $k \cdot p$ parameter. These results are similar with the TDPs induced by breaking time reversal symmetry in centrosymmetric system. ${ }^{3}$
