## ABSTRACT

Your readers will read your abstract in order to decide whether or not to read the entire paper. Make it short, but informative: include your task name, a characterization of your approach, and a very brief statement of the main insights your achieved.

## 1 INTRODUCTION

Your MediaEval Working Notes paper is two pages long, plus and extra page for references. The paper includes information on your algorithm and your results, as well as an analysis of your results, and a brief summary of the insights that you have gained, and your plans for future work.

This document is an example of the format to use for MediaEval 2020. It is a modification of the “new” ACM template. Martha (email above) is responsible for the contents. We are also including in this document some handy tips that we hope will help you in writing your overview paper.

We advise you to make the title of your MediaEval Working Notes paper informative. Many teams like to include the team name in the title. However, it attracts more readers if the title contains information about what is actually done in the paper, rather than the team name.

The introduction should explain the task briefly and cite the overview paper. The overview paper explains the task in depth. By citing the overview paper you save space explaining the task details and the data set, as you would do in a conference papers. Your task organizers will provide you with the paper with the release of the test data.

## 2 RELATED WORK

After the introduction comes the related work. Think about which already existing paper is most closely related to yours. Be sure to cite that paper. Include a statement of whether you are applying the approach of this paper, or whether you are innovating beyond this paper. There may be more than one closest paper. Some authors will choose to fold the related work section into the introduction, in order to save space.

Note the difference in indentation. The first line of the first paragraph of a section is not indented. The first line of the second paragraph of a section is indented.

The working notes paper, as mentioned above in Section 1, is two pages long. At first two pages may seem very short, but in the paper you do not have to describe the task or the data set in detail. Instead you cite the overview paper written by the task organizers, which contains all the necessary information. You can devote the two pages exclusively to presenting the motivation for your approach, explaining your approach, presenting your results, analyzing your results, and presenting an outlook on future work.

## 3 APPROACH

A well-written approach section will explain both *why* design decisions were made and also *how* they were implemented. Remember: You want to maximize the reproducibility of your paper. This means, that it should be possible for other authors to pick up your paper, and recreate the experiments that you did, and achieve the same results that you also achieved.

### 3.1 About Sub-sections

The titles of your sections and sub-sections should be informative: your reader wants to be able to glance at your paper and understand what can be found where. However, they also should not be too long. It's best if section and sub-section titles are short enough to fit on one line.

### 3.2 More on Sub-sections

A section should either have no sub-sections, or it should have more than one sub-section. A section with only one sub-section is unbalanced, and leaves your reader asking why that one sub-section is necessary.

*3.2.1 About Sub-sub-sections.* Of course the option of including sub-sub-sections is also available. The same rule holds. A sub-section should either have no sub-sub-sections, or it should have more than one sub-sub-section.

*3.2.2 More on Sub-sub-sections.* We advise you to avoid using sub-sub-sections. They take up space, and may be confusing rather than helpful for your reader in a short paper.

## 4 RESULTS AND ANALYSIS

Please report your results in your paper. However, in addition to the quantitative results, it is also very important that you include a description of the qualitative insight that you gained by participating in the task.

You can carry out, for example, a failure analysis: inspect key examples, and try to arrive at a generalization of the source of the shortcomings of your algorithm. It is not necessary to use exactly the same sections here, but we include them as examples.

### 4.1 Formatting Information

This sub-section contains a list of issues that you should think about when writing your paper.

- Use short and simple sentences. When it doubt, express a thought in two short sentences, rather than one long one.
- Please spell check and grammar check your paper.
- Please check for widows and orphans. In other words, look for cases in which a section title or a single word is stranded at the bottom of a page or at the top of the next page. Wikipedia gives more information about widows and orphans.
- Please don't use .bibtex directly from the Web without reading it. Instead, go through your .bibtex carefully and make sure that your references are both complete and consistent.

Do not end a section with an list or with a table. Good style demands that a section includes a final sentence which ties the content of the list or table back to what is being discussed in the text.

### 4.2 Other Information

We take this opportunity to remind you that any paragraph you write should consist of more than one sentence. Paragraphs should always contain, like this one does, at least two sentences.

ACM tells us, "You can use whatever symbols, accented characters, or non-English characters you need anywhere in your document; you can find a complete list of what is available in the *LaTeX User's Guide* [1]." In the following section, there is more information from the original ACM version of this sample file.

## 5 EVEN MORE INFORMATION

### 5.1 Math Equations

A formula that appears in the running text is called an inline or in-text formula. It is produced by the **math** environment, which can be invoked with the usual `\begin . . . \end` construction or with the short form `$ . . . $`. You can use any of the symbols and structures, from  $\alpha$  to  $\omega$ , available in *LaTeX* [1]; this section will simply show a few examples of in-text equations in context. Notice how this equation:  $\lim_{n \rightarrow \infty} x = 0$ , set here in in-line math style, looks slightly different when set in display style. (See next section).

A numbered display equation—one set off by vertical space from the text and centered horizontally—is produced by the **equation** environment. Again, in either environment, you can use any of the symbols and structures available in *LaTeX*; this section will just give a couple of examples of display equations in context. First, consider

the equation, shown as an inline equation above:

$$\lim_{n \rightarrow \infty} x = 0 \quad (1)$$

Notice how it is formatted somewhat differently in the **display-math** environment.

### 5.2 Tables

We include Table 1 so that you have an example of a table. To set a wider table, which takes up the whole width of the page's live area, use the environment **table\*** to enclose the table's contents and the table caption.

### 5.3 Figures

No sample paper would be complete without a graphic illustrating a fly. We have commented out the code to insert graphics, but you can see it if you look at the source.

As was the case with tables, you may want a figure that spans two columns. To do this, and still to ensure proper "floating" placement of tables, use the environment **figure\*** to enclose the figure and its caption. And don't forget to end the environment with **figure\***, not **figure**!

## 6 DISCUSSION AND OUTLOOK

You have arrived at the end of your MediaEval Working Notes paper. As mentioned above, make sure that your paper includes insights that you have gained via your participation. Remember: Sometimes the most interesting results are actually negative results. Please think carefully about those aspects of your approach that did not work as you expected. Even if you are disappointed by these aspects, the lessons you learned may be valuable for other researchers moving forward. Please describe them here, focusing on what you feel are the most valuable points.
