1 Maxwell's Equations

We briefly revisit the fundamental equations governing the field of electrodynamics; a comprehensive treatment of the electrodynamics of continuous media can be found in Ref. [1]. Let \check{e} and b denote the electric and magnetic field and let d and h denote the charge and current potential. Furthermore, let q and j be the total charge density and current density. The quantities σ and k are the corresponding counterparts on a surface of discontinuity, namely the surface charge density and current. In a domain $\mathcal{B} \subseteq \mathbb{R}^3$, Maxwell's equations can be written as

$$\operatorname{div}(\boldsymbol{d}) = q , \quad \forall \boldsymbol{\check{x}} \in \mathcal{B} , \tag{1}$$

$$\operatorname{curl}(\boldsymbol{h}) - \boldsymbol{d}_{,t} = \boldsymbol{j} , \quad \forall \boldsymbol{\check{x}} \in \mathcal{B} ,$$

$$\tag{2}$$

$$\operatorname{div}(\boldsymbol{b}) = 0 , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B} , \qquad (3)$$

$$\operatorname{curl}(\check{\boldsymbol{e}}) + \boldsymbol{b}_{,t} = \boldsymbol{0} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B} .$$

As in the main text, the *check* symbol is used to distinguish the electric field and positions from their corresponding counterparts in the dimensionally-reduced theory, as they are the only quantities

that appear in both theories. On a surface of discontinuity S with normal \bar{n} , moving at velocity \bar{v} , Maxwell's equations give rise to the jump conditions

$$\bar{\boldsymbol{n}} \cdot \llbracket \boldsymbol{d} \rrbracket = \sigma , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} , \tag{5}$$

$$\bar{\boldsymbol{n}} \times \llbracket \boldsymbol{h} \rrbracket + \bar{\boldsymbol{v}} \cdot \bar{\boldsymbol{n}} \llbracket \boldsymbol{d} \rrbracket = \boldsymbol{k} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} , \qquad (6)$$

$$\bar{\boldsymbol{n}} \cdot [\![\boldsymbol{b}]\!] = 0 , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} ,$$

$$\tag{7}$$

$$\bar{\boldsymbol{n}} \times \llbracket \check{\boldsymbol{e}} \rrbracket + \bar{\boldsymbol{v}} \cdot \bar{\boldsymbol{n}} \llbracket \boldsymbol{b} \rrbracket = \boldsymbol{0} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} .$$

Here, $\llbracket \bullet \rrbracket = (\bullet)^+ - (\bullet)^-$ denotes the jump across the surface of discontinuity, where $(\bullet)^{\pm}$ indicates evaluation in the bulk domain above and below the surface of discontinuity. The superscript "+" refers to the side to which \bar{n} points, and "-" refers to the opposing side. A more detailed discussion about jump conditions at surfaces of discontinuities can be found in Ref. [2].

Equations (1)-(8) are not well-posed—there are more unknowns than equations. Thus, we assume there exists an aether frame in which the so-called aether relations hold,

$$\boldsymbol{d} = \varepsilon_0 \check{\boldsymbol{e}} \;, \tag{9}$$

$$\boldsymbol{h} = \frac{1}{\mu_0} \boldsymbol{b} \;, \tag{10}$$

where ε_0 and μ_0 denote universal constants, often referred to as permittivity and permeability of free space. As discussed by Kovetz [1], these relations hold true in any aether frame and are independent of the material occupying the point under consideration. With the aether relations, Eqs. (9) and (10), Eqs. (1)–(8) become well-posed. We emphasize here that the charge densities q and σ as well as the charge current densities j and k refer to the *total* charge and current densities.

To account for a material specific response to external fields, we split the charge and current densities into free and bound contributions:

$$q = q_{\rm f} + q_{\rm b} , \qquad (11)$$

$$\sigma = \sigma_{\rm f} + \sigma_{\rm b} , \qquad (12)$$

$$\boldsymbol{j} = \boldsymbol{j}_{\mathrm{f}} + \boldsymbol{j}_{\mathrm{b}} , \qquad (13)$$

$$\boldsymbol{k} = \boldsymbol{k}_{\rm f} + \boldsymbol{k}_{\rm b} , \qquad (14)$$

where the subscripts "f" and "b" denote free and bound quantities, respectively. Correspondingly, we split the charge and current potentials into free and bound contributions:

$$\boldsymbol{d} = \boldsymbol{d}_{\mathrm{f}} - \boldsymbol{p} \;, \tag{15}$$

$$\boldsymbol{h} = \boldsymbol{h}_{\rm f} + \boldsymbol{m} \; , \tag{16}$$

where p and m denote the polarization and magnetization field, respectively, and the negative sign in front of p is purely conventional. Equations (1) and (2) can be derived from charge conservation such that they hold for both the free and bound fields separately. Therefore, equivalently to Eqs. (1), (2), (5), and (6), we find

$$\operatorname{div}(\boldsymbol{d}_{\mathrm{f}}) = q_{\mathrm{f}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B} , \qquad (17)$$

$$\operatorname{curl}(\boldsymbol{h}_{\mathrm{f}}) - \boldsymbol{d}_{\mathrm{f},t} = \boldsymbol{j}_{\mathrm{f}} , \quad \forall \boldsymbol{\check{x}} \in \boldsymbol{\mathcal{B}} ,$$

$$(18)$$

$$\bar{\boldsymbol{n}} \cdot [\![\boldsymbol{d}_{\mathrm{f}}]\!] = \sigma \quad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} \quad ,$$

$$\tag{19}$$

$$\bar{\boldsymbol{n}} \times \llbracket \boldsymbol{h}_{\mathrm{f}} \rrbracket + \bar{\boldsymbol{v}} \cdot \bar{\boldsymbol{n}} \llbracket \boldsymbol{d}_{\mathrm{f}} \rrbracket = \boldsymbol{k}_{\mathrm{f}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} .$$

The remaining Maxwell's equations are unaffected by the split into free and bound fields. However, we note that the aether relations, Eqs. (9) and (10), do not apply to the free fields. Therefore, the problem is currently not well-posed and requires additional constitutive relations.

Before introducing constitutive relations for the polarization and magnetization fields, we specialize Eqs. (3), (4), (7), (8) and (17)–(20) to the case of electrostatics. The electrostatic equations can be derived by assuming that $d_{f,t}$, $b_{,t}$, j_f , \bar{v} , and k_f vanish identically everywhere [1]. In order to decouple Eqs. (17)–(20) from Eqs. (3), (4), (7), and (8), we assume that the charge densities q_f and σ_f , and polarization p are independent of the magnetic field b. According to the framework of linear irreversible thermodynamics, the latter condition implies that the magnetization m has to vanish [3], yielding the electrostatic equations

$$\operatorname{div}(\boldsymbol{d}_{\mathrm{f}}) = q \ , \quad \forall \boldsymbol{\check{x}} \in \mathcal{B} \ , \tag{21}$$

$$\operatorname{curl}(\check{e}) = \mathbf{0} , \quad \forall \check{x} \in \mathcal{B} , \qquad (22)$$

$$\bar{\boldsymbol{n}} \cdot [\![\boldsymbol{d}_{\mathrm{f}}]\!] = \sigma , \quad \forall \boldsymbol{\check{x}} \in \mathcal{S} ,$$

$$\tag{23}$$

$$\bar{\boldsymbol{n}} \times [\![\check{\boldsymbol{e}}]\!] = \boldsymbol{0} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} .$$

The approach described in the above paragraph to derive the electrostatic equations is restrictive. However, the electrostatic equations are also valid under an appropriate separation of time scales [4]. Let ℓ denote a characteristic length scale and τ a characteristic dynamical time scale associated with a phenomena that one wishes to study. Non-dimensionalization of Maxwell's equations shows that $\tau_{\rm e} = \varepsilon_0/\sigma_{\rm c}$ is the characteristic charge relaxation time scale, where $\sigma_{\rm c}$ is the conductivity, and $\tau_{\rm m} = \mu_0 \sigma_{\rm c} \ell^2$ is the magnetic diffusion time scale [4]. If $\ell^2/c^2 \ll \tau^2$, where c is the speed of light, and $\tau_{\rm e} > \tau_{\rm m}$, Maxwell's equations decouple and simplify to the electrostatic equations Eqs. (21)–(24) as discussed in detail in Ref. [4].

To close Eqs. (21)–(24), we introduce the constitutive relation of a linear dielectric [3],

$$\boldsymbol{p} = (\varepsilon - \varepsilon_0) \, \check{\boldsymbol{e}} \, . \tag{25}$$

Using Eq. (15), we then find

$$d_{\rm f} = \varepsilon \check{e}$$
 . (26)

Therefore, the electrostatic equations, Eqs. (21)-(24), become

$$\operatorname{div}(\varepsilon \check{\boldsymbol{e}}) = q_{\mathrm{f}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B} , \qquad (27)$$

$$\operatorname{curl}(\check{\boldsymbol{e}}) = \boldsymbol{0} \quad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B} \quad , \tag{28}$$

$$\bar{\boldsymbol{n}} \cdot [\![\boldsymbol{\varepsilon} \check{\boldsymbol{e}}]\!] = \sigma_{\mathrm{f}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} , \qquad (29)$$

$$\bar{\boldsymbol{n}} \times [\![\check{\boldsymbol{e}}]\!] = \boldsymbol{0} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} .$$

Both in the bulk domain \mathcal{B} and on the surface of discontinuity \mathcal{S} , Eqs. (27)–(30) yield four equations for three unknowns. According to the Helmholtz decomposition however, every sufficiently smooth vector field can be decomposed into a curl-free field and a divergence-free field,

$$\check{\boldsymbol{e}} = -\operatorname{grad}(\check{\phi}) + \operatorname{curl}(\boldsymbol{A}) , \qquad (31)$$

where ϕ and A are some scalar and vector fields, respectively. Furthermore, according to Eq. (27) and (28), we can set, without loss of generality, A = 0, such that we are left with

$$-\varepsilon \Delta \dot{\phi} = q_{\rm f} , \quad \forall \check{x} \in \mathcal{B} ,$$

$$\tag{32}$$

$$-\bar{\boldsymbol{n}} \cdot \llbracket \varepsilon \operatorname{grad}(\phi) \rrbracket = \sigma_{\mathrm{f}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} , \qquad (33)$$

$$\llbracket \phi \rrbracket = 0 \quad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S} \; , \tag{34}$$

where we now identify $\check{\phi}$ as the electric potential. Equation (34) is not derived here but follows from the integral form of Coulomb's law for continuous charges [5]. Furthermore, we assume that the permittivity is constant in the bulk domain \mathcal{B} and omit the condition following from Eq. (30) as it is trivially satisfied due to Eq. (34). Equations (32)–(34) serve as the starting point for the derivation of the $(2 + \delta)$ -dimensional theory, where we will omit the subscript f for free quantities for brevity.

2 Derivation of an Effective Surface Equation for Gauss' Law

In this section, a detailed derivation of the $(2 + \delta)$ -dimensional theory for the electrostatics of thin films is provided. We begin by revisiting the three-dimensional theory governing the electrostatics of thin films and subsequently apply the dimension reduction procedure introduced in Sec. 3.2 of the main text.

2.1 Governing Equations

The equations governing the electrostatics of a thin film, schematically shown in Fig. 1, are given by

$$\Delta \check{\phi}_{\mathrm{B}^{-}} = -q_{\mathrm{B}^{-}} / \varepsilon_{\mathrm{B}^{-}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B}^{-} , \tag{35}$$

$$\llbracket \phi \rrbracket = 0 \qquad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S}^- , \qquad (36)$$

$$\bar{\boldsymbol{n}}^+ \cdot [\![\boldsymbol{\varepsilon} \check{\boldsymbol{e}}]\!] = \sigma^- \qquad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S}^- , \qquad (37)$$

$$\varepsilon_{\mathrm{M}}\Delta\phi_{\mathrm{M}} = 0 \qquad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{M} , \qquad (38)$$

$$\bar{\boldsymbol{n}}^{-} \cdot \llbracket \varepsilon \check{\boldsymbol{e}} \rrbracket = \sigma^{+} \qquad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S}^{+} , \qquad (39)$$

$$\llbracket \dot{\phi} \rrbracket = 0 \qquad , \quad \forall \check{x} \in \mathcal{S}^+ , \tag{40}$$

$$\Delta \dot{\phi}_{\mathrm{B}^+} = -q_{\mathrm{B}^+} / \varepsilon_{\mathrm{B}^+} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{B}^+ .$$

$$\tag{41}$$

The superscripts \pm indicate quantities above and below the membrane (Fig. 1), the subscripts B^{\pm} and M indicate the two bulk domains and membrane, respectively, \bar{n}^{\pm} denotes the normal to S^{\pm} , and all other symbols carry the same meaning as in Sec. 1. The *check* symbol is used on some quantities to distinguish them from their counterparts in the dimensionally-reduced theory.

Equations (35)–(41) are closed with the boundary conditions on the lateral surface $S_{||}$ with outward-pointing normal ν ,

$$\check{\phi}_{\mathrm{M}} = \bar{\phi}_{\mathrm{M}} , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S}_{||\mathrm{D}} ,$$

$$\tag{42}$$

$$-\boldsymbol{\nu} \cdot \operatorname{grad}(\check{\phi}_{\mathrm{M}}) = \bar{e} \quad , \quad \forall \check{\boldsymbol{x}} \in \mathcal{S}_{||\mathrm{N}} \; , \tag{43}$$

where $\bar{\phi}_{\mathrm{M}}$ and \bar{e} are the prescribed potential and electric field, respectively, and $S_{||} = S_{||D} \cup S_{||N}$ and $S_{||D} \cap S_{||N} = \emptyset$. The remaining boundary conditions for $\check{\phi}_{\mathrm{B}^{\pm}}$ are of no consequence for the derivation of the dimensionally-reduced theory and are thus omitted here.

2.2 Differential Geometry Preliminaries

In the following derivations, vectors and tensors are denoted by bold letters and matrices are denoted using square brackets. Subscripts and superscripts indicate covariant and contravariant components, respectively, and repeated sub- and superscripts imply Einstein's summation convention. The tensors considered in this article are symmetric such that the order of co- and contravariant components is inconsequential and is therefore not explicitly indicated. Greek indices take values $\{1, 2\}$ while Latin indices take values $\{1, 2, 3\}$. For some function f, the short-hand notation $f(\zeta^{\alpha})$ implies $f(\zeta^1, \zeta^2)$ and an analogous short-hand notation is used with Latin indices. Partial derivatives are denoted by a comma, covariant derivatives of a vector are denoted by a vertical bar, and *surface* covariant derivatives of vectors and tensors are denoted by colons and semicolons, respectively.

We begin by recalling that the assumption of Kirchhoff-Love kinematics implies the position vector \boldsymbol{x} can be expressed as

$$\boldsymbol{x} = \boldsymbol{x}_0 P_0(\boldsymbol{\theta}(\boldsymbol{\zeta}^3)) + \frac{\delta}{2} \boldsymbol{n} P_1(\boldsymbol{\theta}(\boldsymbol{\zeta}^3)) , \qquad (44)$$

where \boldsymbol{x}_0 denotes a point on the mid-surface, \boldsymbol{n} is the normal to the mid-surface, $P_i(\theta(\zeta^3))$ is the *i*th Chebsyhev polynomial, and $\theta: \Xi \to (-1, 1)$ maps from the parametric domain Ξ onto the domain of the Chebsyhev polynomials. Furthermore, recall that the coefficients \boldsymbol{x}_0 and \boldsymbol{n} depend on the mid-plane parametrization ζ^{α} . In the following, we omit, where convenient, the 0th order Chebsyhev polynomial, $P_0(\theta) = 1$, and the explicit dependence of θ on ζ^3 .

Using Eq. (44), we can now define the in-plane, covariant basis vectors as

$$\boldsymbol{g}_{\alpha} \coloneqq \frac{\partial \boldsymbol{x}}{\partial \zeta^{\alpha}} \tag{45}$$

$$= \boldsymbol{a}_{\alpha} + \frac{\delta}{2} \boldsymbol{n}_{,\alpha} P_1(\theta) \tag{46}$$

$$= \boldsymbol{a}_{\alpha} - \frac{\delta}{2} b_{\alpha}^{\beta} \boldsymbol{a}_{\beta} P_{1}(\theta) , \qquad (47)$$

where we defined $\mathbf{a}_{\alpha} \coloneqq \partial \mathbf{x}_0 / \partial \zeta^{\alpha}$ and used the Weingarten formula with the curvature tensor components $b_{\alpha\gamma} = \mathbf{a}_{\alpha,\gamma} \cdot \mathbf{n}$ and the contravariant metric tensor $a^{\gamma\beta}$, such that $b_{\alpha}^{\beta} = b_{\alpha\gamma}a^{\gamma\beta}$. The third basis vector is calculated to be

$$\boldsymbol{g}_3 \coloneqq \frac{\partial \boldsymbol{x}}{\partial \zeta^3} = \boldsymbol{n} \;, \tag{48}$$

implying that $\bar{n}^+ = \bar{n}^- = n$. Restricting the basis vectors in Eqs. (47) and (48) to the mid-surface yields

$$\left. \boldsymbol{g}_{\alpha} \right|_{\ell^3 = 0} = \boldsymbol{a}_{\alpha} \;, \tag{49}$$

$$g_3|_{\zeta^3=0} = n$$
 . (50)

Therefore, we identify $\{a_{\alpha}, n\}$ as the basis on the mid-surface, satisfying $a_{\alpha} \cdot n = 0$.

In curvilinear coordinates, the Laplacian of the potential $\check{\phi}$ can be written as [6]

$$\Delta \check{\phi} = \check{\phi}_{,i|j} \, g^{ij} \tag{51}$$

$$= \left(\check{\phi}_{,ij} - \Gamma^k_{ij}\check{\phi}_{,k}\right)g^{ij},\tag{52}$$

where $\check{\phi}_{,i} = \partial \check{\phi} / \partial \zeta^i$, $\check{\phi}_{,i}|_j$ is the covariant derivative of $\phi_{,i}$, $g^{ij} = g^i \cdot g^j$ is the contravariant metric, and Γ^k_{ij} is the Christoffel symbol of the second kind, defined as

$$\Gamma_{ij}^k = \boldsymbol{g}_{i,j} \cdot \boldsymbol{g}^k \ . \tag{53}$$

Here, \boldsymbol{g}^k denotes the contravariant basis vector, related to the covariant basis vectors by

$$\boldsymbol{g}^k = g^{kl} \boldsymbol{g}_l \ . \tag{54}$$

From $[g^{ij}] = [g_{ij}]^{-1}$ and Eq. (47), it becomes apparent that g^{ij} , g^k , and Γ_{ij}^k are rational polynomials. This complicates evaluation of the inner products required in the proposed dimension reduction method. Therefore, we find approximate, non-rational polynomial expressions for these quantities, requiring the truncation of small terms using the geometric properties of the thin film. To that end, we introduce the principal curvatures of a surface, denoted by κ_{α} . Furthermore, we define the mean and Gaussian curvatures as the trace and determinant of the curvature tensor \boldsymbol{b} :

$$H = \frac{1}{2} \operatorname{tr} \boldsymbol{b} , \qquad (55)$$

$$K = \det \boldsymbol{b} , \qquad (56)$$

where tr and det denote the trace and determinant, respectively. The mean and Gaussian curvatures are related to the principal curvatures by

$$H = \frac{1}{2} \left(\kappa_1 + \kappa_2 \right) \quad , \tag{57}$$

$$K = \kappa_1 \kappa_2 . (58)$$

We now make the assumption that the principal curvatures are small compared to the thickness of the thin film, i.e.

$$(\delta \kappa_{\alpha})^2 \ll 1 , \qquad (59)$$

as is often found for lipid membranes. While Eq. (59) also implies

$$(\delta H)^2 \ll 1 , \qquad (60)$$

$$\delta^2 |K| \ll 1 , \qquad (61)$$

the former two inequalities do not imply Eq. (59). However, Eq. (59) allows us to further simplify our derivations in the following.

In particular, we need to estimate the order of magnitude of the curvature tensor **b**. Denoting the orthonormal eigenvectors of **b** by $l_{\alpha} = l^{\alpha}$, the spectral decomposition of the curvature tensor becomes

$$\boldsymbol{b} = \sum_{\alpha=1}^{2} \kappa_{\alpha} \boldsymbol{l}_{\alpha} \otimes \boldsymbol{l}_{\alpha} .$$
(62)

Using Eq. (62), we can estimate the order of magnitude of \boldsymbol{b} acting on an arbitrary symmetric tensor $\boldsymbol{A} = A_{\alpha}^{\beta} \boldsymbol{l}^{\alpha} \otimes \boldsymbol{l}_{\beta}$. Taking the inner product of \boldsymbol{A} and \boldsymbol{b} , we find

$$(\delta \boldsymbol{b})^2 : \boldsymbol{A} = \sum_{\alpha=1}^2 (\delta \kappa_{\alpha})^2 A_{\alpha}^{\alpha} , \qquad (63)$$

where the colon indicates a double contraction. Similarly, we find

$$\boldsymbol{I}_0: \boldsymbol{A} = A^{\alpha}_{\alpha} , \qquad (64)$$

where $I_0 = a_\alpha \otimes a^\alpha = l_\alpha \otimes l^\alpha$ is the unit tensor on the tangent plane to S_0 . The quantities in Eqs. (63) and (64) are invariant, implying

$$(\delta \boldsymbol{b})^2 : \boldsymbol{A} \ll \boldsymbol{I}_0 : \boldsymbol{A} . \tag{65}$$

Next, we derive an order of magnitude estimate for the components of the curvature tensor. The Cayley-Hamilton theorem applied to the curvature tensor reads [6]

$$\boldsymbol{b}^2 - 2H\boldsymbol{b} + K\boldsymbol{I}_0 = \boldsymbol{0} \ . \tag{66}$$

Multiplying Eq. (66) through by $\delta^3 b$ and substituting Eq. (66) back, we find

With Eqs. (60) and (61), Eq. (67) is an estimate of the order of magnitude of the cube of the curvature tensor when compared to **b** and **I**. In the remainder of the derivation, we often discard small terms using Eqs. (60), (61), (65), and (67). For notational simplicity, the omitted terms are replaced by $\mathcal{O}((\delta\kappa)^n)$ for some integer n and $\kappa = \max_{\alpha}(|\kappa_{\alpha}|)$ to indicate the order of truncation.

We are now equipped to find an approximate polynomial expression for g^k . Equations (47) and (48) yield

Furthermore, from Eq. (69), it immediately follows that

Given approximate expressions for g^{ij} and g^k , we are left with finding approximate expressions for the Christoffel symbols Γ_{ij}^k . With Eqs. (46), (76) and (78), the dot product in Eq. (53) can

be evaluated. However, considering the structure of $g^{\alpha\beta}$, we only require the following Christoffel symbols to evaluate Eq. (52):

In Eq. (79), ${}^{0}\Gamma^{\gamma}_{\alpha\beta} := a_{\alpha,\beta} \cdot a^{\gamma}$ denotes the Christoffel symbol on the mid-surface and a semicolon indicates the surface covariant derivative of a tensor. Moreover, to obtain Eqs. (79) and (80), we used Eq. (67), the relations

2.3 Dimension Reduction

We now apply the dimension reduction procedure introduced in Sec. 3.2 of the main text to find the dimensionally-reduced equation corresponding to Eq. (38). This requires evaluating Eq. (52)using the expressions for the inverse metric and Christoffel symbols derived in Sec. 2.2 as well as the expansion of the potential introduced in Sec. 4 of the main text:

where the surface Laplacian is defined as $\Delta^{s}\phi_{0} = (\phi_{0,\alpha})_{;\beta} a^{\alpha\beta}$, with the colon indicating the surface covariant derivative of a vector. The term highlighted in green is small based on Eqs. (60) and (61) and the terms highlighted in blue are negligible based on dimensional arguments. Namely, we assume there exists a characteristic in-plane length scale ℓ over which the curvature and potential vary, satisfying

Using Eqs. (59) and (103) and noting that Eq. (101) is invariant, non-dimensionalization allows us to neglect all terms highlighted in blue in Eq. (101). Also note that Eq. (102) is truncated at first

polynomial order which is equivalent to taking the inner product of the Laplacian with the zeroth order Chebyshev polynomial. Therefore, we can write the zeroth order contribution of Eq. (38) as

(37) and (39) are used to find expressions for ϕ_1 and ϕ_2 . To this end, we substitute the potential expansion, Eq. (88), into Eqs. (37) and (39), yielding

where $\langle \varepsilon_{\rm B} \boldsymbol{e}_{\rm B} \rangle^{\rm M} = \frac{1}{2} (\varepsilon_{\rm B^+} \boldsymbol{e}_{\rm B^+}|_{\mathcal{S}^+} + \varepsilon_{\rm B^-} \boldsymbol{e}_{\rm B^-}|_{\mathcal{S}^-})$ and $[\![\varepsilon_{\rm B} \boldsymbol{e}_{\rm B}]\!]^{\rm M} = \varepsilon_{\rm B^+} \boldsymbol{e}_{\rm B^+}|_{\mathcal{S}^+} - \varepsilon_{\rm B^-} \boldsymbol{e}_{\rm B^-}|_{\mathcal{S}^-}$ denote averages and jumps across the membrane, respectively. Equations (104), (107), and (108) are independent of the parametric direction ζ^3 and therefore, constitute the $(2 + \delta)$ -dimensional theory.

Finally, we derive effective boundary conditions corresponding to the three-dimensional boundary conditions in Eqs. (42) and (43). Expressing the expansion of the prescribed potential in terms of Chebyshev polynomials as

$$\left(112\right)$$

$$\stackrel{0}{=}\nu^{\alpha}\left(\phi_{0,\beta}\left(\delta^{\beta}_{\alpha}+\frac{\delta^{2}}{4}Hb^{\beta}_{\alpha}\right)+\frac{\delta}{4}\phi_{1,\beta}b^{\beta}_{\alpha}+\frac{\delta^{2}}{16}\phi_{2,\beta}b^{\beta}_{\gamma}b^{\gamma}_{\alpha}+\mathcal{O}\left((\delta\kappa)^{2}\right)\right),\qquad(114)$$

where the term highlighted in orange can be neglected using Eqs. (65) and (66). Expanding the prescribed electric field as $\bar{e} = \sum_{i=0}^{\infty} \bar{e}_i P_i(\theta)$ and taking the inner product of Eq. (114) with the zeroth order Chebyshev polynomial, Eq. (43) reduces to

where the equality only holds to order $\mathcal{O}((\delta \kappa)^2)$. When applying Eq. (115), we assume that ϕ_1 and ϕ_2 are determined by Eqs. (107) and (108), respectively. Alternatively, they could be determined by using the inner product of Eq. (43) with the first and second order Chebshev polynomial.

3 Derivation of Analytical Solutions

In the following, the analytical solutions to the exact and $(2+\delta)$ -dimensional theories used in Sec. 5.1 of the main text are derived. For the flat geometry, the $(2 + \delta)$ -dimensional theory is exact but for the cylinder and sphere, it deviates from the exact theory. Due to the curvature of the cylinder and sphere, the potential in the interior of the membrane does not just vary linearly and is thus not captured exactly by the $(2 + \delta)$ -dimensional theory. However, the error in the $(2 + \delta)$ -dimensional theory decreases quadratically with increasing radius of the geometry.

3.1 Flat Geometry

Consider the flat geometry described in Sec. 5.1.1 of the main text. The governing equations for the three-dimensional theory are

The governing equations of the $(2 + \delta)$ -dimensional theory, Eqs. (104) and Gauss' law in the bulk domains, simplify to

which enforce, by construction, the jump conditions in Eqs. (122) and (124), leaving us with the conditions for potential continuity on S^{\pm} :

For the dimensionally-reduced theory, the governing equations are

Comparison of the bulk solutions of the three-dimensional and $(2+\delta)$ -dimensional theories shows exact agreement for $r \ge R_0^+$, i.e. $\phi_{B^+} = \check{\phi}_{B^+}$. However, for $r < R_0^+$, the $(2+\delta)$ -dimensional theory is not exact. Defining the non-dimensional curvature as

Evaluating the inner product of Eq. (176) proves difficult such that we instead expand the first logarithmic term:

$$\phi_0 - \phi_2 = \frac{\bar{e}R_A \delta R_0}{2\chi R_0^- R_0^+} \left(1 - \frac{\mu}{2}\right) + \frac{R_0 \sigma^-}{2C_M R_0^+} \left(1 - \frac{\mu}{2}\right) - \left(\bar{e}R_A + \frac{1}{\varepsilon_B} \left(R_0^+ \sigma^+ + R_0^- \sigma^-\right)\right) \ln\left(\frac{R_0^+}{R_E}\right) .$$
(186)

Comparing Eq. (186) to Eq. (182), Eq. (171) to Eq. (183), and Eq. (172) to Eq. (184) shows that the error between the exact and $(2 + \delta)$ -dimensional theories scales as $\mathcal{O}(\mu^2)$, again consistent with Eq. (59).

3.3 Spheres

Consider the spherical geometry described in Sec. 5.1.3 of the main text. The governing equations for the three-dimensional theory in spherical coordinates are

$$\frac{\mathrm{d}}{\mathrm{d}r}r^2\frac{\mathrm{d}\check{\phi}^-}{\mathrm{d}r} = 0 , \quad \forall r \in (R_\mathrm{A}, R_0^-) , \qquad (187)$$

$$\frac{\mathrm{d}}{\mathrm{d}r}r^2 \frac{\mathrm{d}\phi_{\mathrm{M}}}{\mathrm{d}r} = 0 , \quad \forall r \in (R_0^-, R_0^+) , \qquad (188)$$

$$\frac{\mathrm{d}}{\mathrm{d}r}r^2\frac{\mathrm{d}\check{\phi}^-}{\mathrm{d}r} = 0 , \quad \forall r \in (R_0^+, R_\mathrm{E}) .$$
(189)

The interface and boundary conditions remain as in the cylindrical case and are thus given by Eqs. (147)-(152). Upon applying the boundary conditions, Eqs. (151) and (152), the general form of the solution becomes

$$\check{\phi}^- = \bar{e} \frac{R_{\rm A}^2}{r} + \check{B}^- , \qquad (190)$$

$$\check{\phi}_{\rm M} = -\frac{\check{C}}{r} + \check{D} , \qquad (191)$$

$$\check{\phi}^+ = \frac{\check{A}^+}{R_{\rm E}} \left(\frac{R_{\rm E}}{r} - 1\right) , \qquad (192)$$

with the remaining constants determined using the interface conditions, Eqs. (147)-(150):

$$\check{A}^{+} = \frac{1}{\varepsilon_{\rm B}} \left(\sigma^{+} \left(R_{0}^{+} \right)^{2} + \sigma^{-} \left(R_{0}^{-} \right)^{2} \right) + e R_{\rm A}^{2} , \qquad (193)$$

$$\check{B}^{-} = \frac{\delta}{R_{0}^{+}R_{0}^{-}} \left(\frac{eR_{A}^{2}}{\chi} + \frac{\sigma}{\varepsilon_{B}} \left(R_{0}^{-} \right)^{2} \right) - \frac{eR_{A}^{2}}{R_{0}^{-}R_{0}^{+}R_{E}} \left(\delta R_{E} + R_{0}^{+}R_{0}^{-} \right)
- \frac{1}{\varepsilon_{B}R_{0}^{+}R_{E}} \left(R_{0}^{+} - R_{E} \right) \left(\sigma^{+} \left(R_{0}^{+} \right)^{2} + \sigma^{-} \left(R_{0}^{-} \right)^{2} \right) , \quad (194)$$

$$\check{C} = -\frac{eR_{\rm A}^2}{\chi} - \frac{\sigma^-}{\varepsilon_{\rm M}} \left(R_0^-\right)^2 , \qquad (195)$$

$$\check{D} = -\frac{1}{R_0^+ \chi} \left(eR_{\rm A}^2 + \frac{\sigma^-}{\varepsilon_{\rm B}} \left(R_0^- \right)^2 \right) - \frac{eR_{\rm A}^2 \left(R_0^+ - R_{\rm E} \right)}{R_0^+ R_{\rm E}} - \frac{\left(R_0^+ - R_{\rm E} \right)}{\varepsilon_{\rm B} R_0^+ R_{\rm E}} \left(\sigma^+ \left(R_0^+ \right)^2 + \sigma^- \left(R_0^- \right)^2 \right) .$$
(196)

For the dimensionally-reduced theory, the governing equations are

$$\frac{\mathrm{d}}{\mathrm{d}r}r^2\frac{\mathrm{d}\phi^-}{\mathrm{d}r} = 0 , \qquad \forall r \in (R_\mathrm{A}, R_0^-) , \qquad (197)$$

$$C_{\rm M} \frac{4}{R_0} \phi_1 + \frac{16}{\delta} C_{\rm M} \phi_2 = 0 , \qquad r = R_0 , \qquad (198)$$

$$\frac{\mathrm{d}}{\mathrm{d}r}r^2\frac{\mathrm{d}\phi^-}{\mathrm{d}r} = 0 , \qquad \forall r \in (R_0^+, R_\mathrm{E}) , \qquad (199)$$

where we have used $H = -1/R_0$. The interface conditions, the governing equations for ϕ_1 and ϕ_2 , as well as the boundary conditions remain the same as in the cylindrical case and are thus given by Eqs. (163)–(166). After applying the boundary conditions, the general form of the solution reads

$$\phi^{-} = e \frac{R_{\rm A}^2}{r} + B^{-} , \qquad (200)$$

$$\phi_{\rm M} = \phi_0 P_0(\theta) + \phi_1 P_1(\theta) + \phi_2 P_2(\theta) , \qquad (201)$$

$$\phi^+ = \frac{A^+}{R_{\rm E}} \left(\frac{R_{\rm E}}{r} - 1\right) , \qquad (202)$$

with the remaining coefficients determined using Eqs. (163)-(166):

$$\phi_{0} = -\frac{\delta^{2}}{8\chi (R_{0} + \delta)} \left(e \left(\frac{R_{A}}{R_{0}^{-}} \right)^{2} + \frac{\sigma^{-}}{\varepsilon_{B}} \right) - \frac{R_{0} \left(R_{0}^{+} - R_{E} \right) e R_{A}^{2}}{R_{0}^{+} \left(R_{0} + \delta \right) R_{E}} - \frac{R_{0} R_{0}^{+} \left(R_{0}^{+} - R_{E} \right) \left(\sigma^{+} + \sigma^{-} \right)}{\varepsilon_{B} \left(R_{0} + \delta \right) R_{E}} + \frac{\delta R_{0} e R_{A}^{2}}{2\chi \left(R_{0} + \delta \right) \left(R_{0}^{-} \right)^{2}} + \frac{R_{0} \sigma^{-}}{2C_{M} \left(R_{0} + \delta \right)} - \frac{\delta \left(R_{0}^{+} - R_{E} \right) R_{0}^{+}}{\left(R_{0} + \delta \right) R_{E}} \left(-e \frac{R_{A}^{2}}{\left(R_{0}^{-} \right)^{2}} + \frac{\left(\sigma^{+} - \sigma^{-} \right)}{\varepsilon_{B}} \right) , \quad (203)$$

$$\phi_1 = -\frac{\delta R_0 e R_A^2}{2\chi \left(R_0 + \delta\right) \left(R_0^-\right)^2} - \frac{R_0 \sigma^-}{2C_M \left(R_0 + \delta\right)} , \qquad (204)$$

$$\phi_2 = \frac{\delta^2 e R_{\rm A}^2}{8\chi \left(R_0 + \delta\right) \left(R_0^-\right)^2} + \frac{\delta \sigma^-}{8C_{\rm M} \left(R_0 + \delta\right)} , \qquad (205)$$

$$A^{+} = eR_{\rm A}^{2} \frac{(R_{0} - \delta)(R_{0}^{+})^{2}}{(R_{0} + \delta)(R_{0}^{-})^{2}} + \frac{(R_{0}^{+})^{2}\sigma^{+}}{\varepsilon_{\rm B}} + \frac{(R_{0}^{+})^{2}(R_{0} - \delta)\sigma^{-}}{\varepsilon_{\rm B}(R_{0} + \delta)},$$
(206)

$$B^{-} = \frac{\delta R_{0}}{(R_{0} + \delta)} \left(\frac{eR_{A}^{2}}{(R_{0}^{-})^{2} \chi} + \frac{\sigma^{-}}{\varepsilon_{M}} \right) - \frac{eR_{A}^{2}}{R_{E}} \frac{R_{0} - \delta}{R_{0} + \delta} \left(\frac{R_{0}^{+}}{R_{0}^{-}} \right)^{2} - eR_{A}^{2} \frac{\delta R_{0}}{(R_{0} + \delta) (R_{0}^{-})^{2}} - \frac{R_{0}^{+}}{\varepsilon_{B}R_{E}} \left(R_{0}^{+} - R_{E} \right) \left(\sigma^{+} + \sigma^{-} \frac{R_{0} - \delta}{R_{0} + \delta} \right) .$$
(207)

The functional forms of the solution of the exact and $(2 + \delta)$ -dimensional theories coincide in the bulk domains such that it is sufficient to compare the coefficients \check{A}^+ and A^+ as well as \check{B}^- and B^- . Expanding the respective expressions around $\mu = 0$ shows that A^+ and B^- are accurate up to order $\mathcal{O}(\mu^2)$, with μ defined in Eq. (175).

To compare the solutions within the membrane, we expand the exact solution in Eq. (191) around $\mu = 0$:

$$\check{\phi}_{\rm M} = -\frac{\dot{C}}{r} + \check{D} \tag{208}$$

$$= -\frac{\check{C}}{R_0 \left(1 + \mu\theta\right)} + \check{D} \tag{209}$$

$$= -\frac{\check{C}}{R_0} \sum_{k=0}^{\infty} (-1)^k \,\mu^k \theta^k + \check{D} \,.$$
(210)

The series converges for $|\mu| < |\theta|^{-1}$, which is satisfied since $\theta \in (-1, 1)$ and $|\mu| < 1$. Therefore, we identify the constant part of $\check{\phi}_{\rm M}$ as $-\frac{\check{C}}{R_0} + \check{D}$ and comparison to $\phi_0 - \phi_2$ shows that the constant contribution of the $(2 + \delta)$ -dimensional theory is accurate up to order $\mathcal{O}(\mu^2)$. Similarly, we can compare $\frac{\check{C}}{R_0}\mu$ to ϕ_1 and $-\frac{\check{C}}{R_0}\mu^2$ to $\frac{1}{2}\phi_2$, also revealing accurate to order $\mathcal{O}(\mu^2)$ as expected by the assumptions of the $(2 + \delta)$ -dimensional theory.
