## I. STABILITY PLOTS

In this appendix we present similar stability plots to those shown in the main text. These are given in Figs. 3, 4 and 7 to 9 for the $B \rightarrow D^{*}$ form factors and in Figs. 1, $2,5,6$ and 10 to 12 for the $B_{s} \rightarrow D_{s}^{*}$ form factors. We also give similar plots to those given in the main text showing variations in our chiral-continuum extrapolation parameters. These are given in Figs. 13 to 18.
