## ANGULAR VELOCITY OF A DISK-SHAPED SWIMMER IN TWO-DIMENSIONAL ODD FLOWS

Here, we derive the angular velocity of a disk-shaped swimmer in a two-dimensional (2D) odd flow. The 2D flat and thin fluid layer is assumed to be perpendicular to the odd viscosity axis e. By defining the effective pressure $\hat{P}=\hat{p}-\hat{\eta}^{\circ} \mathbf{e} \cdot(\nabla \times \hat{\mathbf{v}})$, the stress tensor can be expressed as

\hat{\sigma}_{i j}=-\hat{P} \delta_{i j}+\hat{\eta}^{\mathrm{e}}\left(\partial_{i} \hat{v}_{j}+\partial_{j} \hat{v}_{i}\right)+2 \hat{\eta}^{\mathrm{o}} e_{\ell} \epsilon_{\ell j k} \partial_{k} \hat{v}_{i} \tag{S1}
\end{equation*}
$$

First, we solve the flow around a no-slip disk of radius $a$ rotating with the angular velocity $\hat{\boldsymbol{\Omega}}=\hat{\Omega} \mathbf{e}$. From the no-slip boundary condition $\hat{\mathbf{v}}=\hat{\boldsymbol{\Omega}} \times \mathbf{r}=a \hat{\boldsymbol{\Omega}} \times \mathbf{n}$ at $r=a$, where $\mathbf{n}$ is the normal vector at the disk perimeter, the solution is given by a rotlet singularity

$$
\begin{equation*}
\hat{\mathbf{v}}=\frac{a^{2} \hat{\Omega}}{r^{2}} \mathbf{e} \times \mathbf{r} \tag{S2}
\end{equation*}
$$

Applying the pressureless condition $(\hat{P}=0)$ simplifies the stress tensor $(\mathrm{S} 1)$ to give the traction

$$
\begin{equation*}
\hat{\mathbf{f}}=\hat{\boldsymbol{\sigma}} \cdot \mathbf{n}=-2 \hat{\Omega} \frac{a^{2}}{r^{2}}\left(\hat{\eta}^{\mathrm{e}} \mathbf{e} \times \mathbf{n}+\hat{\eta}^{\mathrm{o}} \mathbf{n}\right) \tag{S3}
\end{equation*}
$$

The net torque acting on the disk contour reads

$$
\begin{equation*}
\hat{\mathbf{T}}=-4 \pi a^{2} \hat{\eta}^{\hat{}} \hat{\Omega} \mathbf{e} \tag{S4}
\end{equation*}
$$

without any modifications due to the odd viscosity, which is consistent with the result of the torque acting on no-slip rigid objects in 2D odd flows [S1].

Applying the obtained traction and torque to the Lorentz reciprocal theorem and using the volume conservation within the swimmer $\left(\int_{\mathcal{C}} d s \mathbf{n} \cdot \mathbf{v}^{\mathrm{s}}=0\right)$, we find

$$
\begin{equation*}
\boldsymbol{\Omega}=-\frac{1}{2 \pi a^{2}} \int_{\mathcal{C}} d s \mathbf{n} \times \mathbf{v}^{\mathrm{s}} \tag{S5}
\end{equation*}
$$

which contains only the intrinsic rotation and is independent of the odd viscosity, as derived for a classical fluid [S2]. In contrast to the precession that occurs in 3D, odd viscosity therefore cannot contribute to the rotation of a swimmer in a 2D incompressible fluid.

## DEFINITION OF THE EULER ANGLES

To describe the angular dynamics of a chiral microswimmer with an intrinsic angular velocity determined in the body frame, it is convenient to work in the swimmer-fixed frame with the basis $\left(\mathbf{e}_{1}, \mathbf{e}_{2}, \mathbf{e}_{3}\right)$ oriented such that $\mathbf{e}_{3} \equiv \mathbf{p}$. We describe the rotation of the swimmer relative to the laboratory frame with the basis $\left(\mathbf{e}_{x}, \mathbf{e}_{y}, \mathbf{e}_{z}\right)$, where $\mathbf{e}_{z} \equiv \mathbf{e}$, using the Euler angles $(\phi, \theta, \psi)[S 3]$ (see Fig. S1). The rotation follows the $z x z$-convention, which is composed of a rotation of angle $\phi$ about $\mathbf{e}_{z}$, a rotation of $\theta$ about the $x$ axis of the resulting reference frame and, a rotation of $\psi$ about the body fixed axis $\mathbf{e}_{3}$. Then the rotation matrix $\mathbf{R}$, which transforms the laboratory frame basis vectors to the body-fixed basis vectors (active transformation) via the relation

\left(\mathbf{e}_{1} \mathbf{e}_{2} \mathbf{e}_{3}\right)=\mathbf{R} \cdot\left(\begin{array}{l}
\mathbf{e}_{x}  \tag{S6}\\
\mathbf{e}_{y}
\end{array} \mathbf{e}_{z}\right)
$$

is given by [S3]

$$
\mathbf{R}=\left(\begin{array}{ccc}
\cos \phi \cos \psi-\sin \phi \cos \theta \sin \psi & -\cos \phi \sin \psi-\sin \phi \cos \theta \cos \psi & \sin \phi \sin \theta  \tag{S7}\\
\sin \phi \cos \psi+\cos \phi \cos \theta \sin \psi & -\sin \phi \sin \psi+\cos \phi \cos \theta \cos \psi & -\cos \phi \sin \theta \\
\sin \theta \sin \psi & \sin \theta \cos \psi & \cos \theta
\end{array}\right)
$$

The inverse transformation is given by

$$
\begin{equation*}
\left(\mathbf{e}_{x} \mathbf{e}_{y} \mathbf{e}_{z}\right)=\mathbf{R}^{T} \cdot\left(\mathbf{e}_{1} \mathbf{e}_{2} \mathbf{e}_{3}\right) \tag{S8}
\end{equation*}
$$

In particular, $\mathbf{e}_{z}$ can be expressed in the swimmer frame as $\mathbf{e}_{z}=\sin \theta \sin \psi \mathbf{e}_{1}+\sin \theta \cos \psi \mathbf{e}_{2}+\cos \theta \mathbf{e}_{3}$.
The angular velocity of the swimmer can be expressed with the derivatives of the Euler angles as [S3]

$$
\begin{equation*}
\boldsymbol{\Omega}=(\dot{\phi} \sin \theta \sin \psi+\dot{\theta} \cos \psi) \mathbf{e}_{1}+(\dot{\phi} \sin \theta \cos \psi-\dot{\theta} \sin \psi) \mathbf{e}_{2}+(\dot{\phi} \cos \theta+\dot{\psi}) \mathbf{e}_{3} \tag{S9}
\end{equation*}
$$

## APPROXIMATE EXPRESSION FOR THE CRITICAL ANGULAR VELOCITY $\Omega_{\text {c }}^{e}$

The critical angular velocity, at which the saddle-node bifurcation takes place in the dynamical system determined by Eq. (12) from the main text can be derived analytically in the limit $|\lambda| \ll 1$. The fixed points $(\bar{\theta}, \bar{\psi})$ correspond to the solutions of equations $\dot{\theta}=0$ and $\dot{\psi}=0$, leading to the conditions

$$
\begin{align*}
& 0=\frac{3 g_{2}(\lambda) B_{2}}{10 a} \sin (2 \bar{\theta})+\Omega^{\mathrm{e}} \sin \gamma \cos \bar{\psi}  \tag{S10}\\
& 0=\frac{3 g_{1}(\lambda) B_{2}}{5 a} \cos \bar{\theta}+\Omega^{\mathrm{e}}\left(\cos \gamma-\frac{\sin \gamma \sin \bar{\psi}}{\tan \bar{\theta}}\right) . \tag{S11}
\end{align*}
$$

Because $g_{2}(\lambda) \ll g_{1}(\lambda)$, Eqs. (S10) and (S11) can only be solved simultaneously if $\cos \bar{\psi} \approx 0$. With $B_{2}<0$ and $\gamma<\pi / 2$ (the situation shown in Fig. 3 in the main text), the saddle-node bifurcation takes place between two fixed points at $\bar{\psi} \approx 3 \pi / 2$, whereas the solution $\bar{\psi} \approx \pi / 2$ gives a single spiral source. We therefore choose $\bar{\psi}=3 \pi / 2$ to analyze the bifurcation. Equation (S11) then simplifies to

$$
\begin{equation*}
\Omega^{\mathrm{e}}(\bar{\theta})=-\frac{3 \lambda B_{2}}{40 a} \frac{\sin (2 \bar{\theta})}{\sin (\gamma+\bar{\theta})} \tag{S12}
\end{equation*}
$$

For a fixed $\Omega^{\mathrm{e}}$, Eq. (S12) is solved by either 1 or 3 values of $\bar{\theta}$. The saddle-node bifurcation, at which 2 solutions vanish, corresponds to a local maximum of $\Omega^{\mathrm{e}}(\bar{\theta})$. From the condition $\partial \Omega^{\mathrm{e}}(\bar{\theta}) / \partial \bar{\theta}=0$, we obtain the position in phase space at which the bifurcation takes place

$$
\begin{equation*}
(\bar{\theta}, \bar{\psi})=\left(\arctan \left(\tan ^{1 / 3} \gamma\right), \frac{3}{2} \pi\right) \tag{S13}
\end{equation*}
$$

which gives the critical value

$$
\begin{equation*}
\Omega_{\mathrm{c}}^{\mathrm{e}}=-\frac{3 \lambda B_{2}}{20 a}\left(\sin ^{2 / 3} \gamma+\cos ^{2 / 3} \gamma\right)^{-3 / 2} \tag{S14}
\end{equation*}
$$

for $0<\gamma<\pi / 2$. Expression (S14) has a minimum at $\gamma=\pi / 4$. The lowest possible critical angular frequency is $\Omega_{\mathrm{c}}^{\mathrm{e}}=(3 / 2)\left|\lambda B_{2}\right| /(20 a)$.

For larger $\lambda$, the critical angular velocity can be determined numerically by analyzing the number of fixed points in the dynamical system. Figure S 2 shows $\Omega_{\mathrm{c}}^{\mathrm{e}}$ as a function of $\lambda$ for three values of $\gamma$. The analytical expression is exact in the limit $\lambda \ll 1$ and the deviation stays within a few percent up to $\lambda=1$.
