

$$\mathbf{Y}(t) = \sqrt{1 - \beta_t} \mathbf{Y}(t-1) + (1 - \sqrt{1 - \beta_t}) f_\phi(\mathbf{X}) + \sqrt{\beta_t} \epsilon_{(t-1) \rightarrow t}$$



Forward process

$\mathbf{Y}(0) \longrightarrow \mathbf{Y}(T)$

$\tilde{\mathbf{Y}}(0) \longleftarrow \tilde{\mathbf{Y}}(T)$

Reverse process

$$\tilde{\mathbf{Y}}(t-1) = \frac{\beta_t \sqrt{\bar{\alpha}_{t-1}}}{1 - \bar{\alpha}_t} \hat{\mathbf{Y}}^t(0) + \frac{(1 - \bar{\alpha}_{t-1}) \sqrt{\alpha_t}}{1 - \bar{\alpha}_t} \tilde{\mathbf{Y}}(t) + \left( 1 + \frac{(\sqrt{\bar{\alpha}_t} - 1)(\sqrt{\alpha_t} + \sqrt{\bar{\alpha}_{t-1}})}{1 - \bar{\alpha}_t} \right) f_\phi(\mathbf{X}) + \sqrt{\tilde{\beta}_t} \epsilon_{t \rightarrow (t-1)}$$
